PLAINTIFF'S MOTION TO AMEND FINAL JUDGMENT

Plaintiff, JERRY GREENBERG ("Greenberg"), moves pursuant to Rule 59(e), Federal Rules of Civil Procedure, for an amendment to the Final Judgment to include prejudgment interest.

On November 16, 2005, the Court entered Final Judgment in this cause. On the same date, the Court entered an Order granting Greenberg's motion for entry of judgment. The motion had asked the Court, among other things, to retain jurisdiction for the purpose of considering prejudgment interest. In the Order, the Court authorized Greenberg, pursuant to Rule 59(e), to file a motion seeking an amendment of the Final Judgment to include prejudgment interest.

Greenberg's memorandum of law in support of this motion is in preparation. Pursuant to the Court's November 16, 2005 Order, a separate motion is being filed that seeks an extension of time for preparation of the memorandum.


