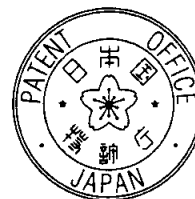

MI-CHUNG AHN

Ms. Mi-Chung Ahn, a national of the Republic of Korea, is at present the Deputy Director (Patent Examiner) of the Genetic Engineering Examination Division, Korean Intellectual Property Office (KIPO), in charge of Patent Examination of Biotechnological Inventions and International Affairs - Budapest Treaty, Genetic Resources, WTO/TRIPS, etc.

Ms. Ahn obtained her Bachelor of Science from the Department of Biochemistry, Yonsei University, Korea in 1984, her M.S. from the Department of Microbiology and Immunology at the University of Illinois at Chicago in the United States in 1988, and in 1995, her Ph.D. from the Department of Immunology and Microbiology, Rush University, Chicago, U.S.A.

Ms. Ahn's early career was as a Researcher at the Rush Medical Cancer Center in Chicago from 1988 to 1989. From 1995 to 1996, she worked on her Post-doctorate at the Biotechnology Analysis Division of the Korea Basic Research Institute, and from 1996 to 1997, at the Gene Therapy Unit of the Biotechnology Analysis Division, Korea Research Institute of Bioscience and Biotechnology. Ms. Ahn became Deputy Director of the Ministry of Commerce, Industry and Energy and was in charge of the Energy Conservation and the Efficiency Division, concerned with industrial energy conservation, climate change, Renewable energy, etc., and the Division for Biotechnology and Fine Chemicals which was involved in the promotion of Bio-industry, R/D of Biotechnology, International Cooperation, International Affairs - Biological Weapon Convention, Biosafety Protocol, etc..

In 1999, Ms. Ahn moved to the Korean Intellectual Property where she is presently the Deputy Director (Patent Examiner) of the Genetic Engineering Examination Division.

In addition, Ms. Ahn is an affiliated professor of the Department of Life Science & Technology at the Pai-Chai University, Korea, and a Committee Member of the Presidential Commission on Sustainable Development (PCSD) of Korea.

SANG-WOO JUN

Mr. Sang-Woo Jun, a national of the Republic of Korea, is at present the Dean of the International Intellectual Property Training Institute (IIPTI), affiliated with the Korean Intellectual Property Office (KIPO), in charge of training planning, training supporting and international training programs.

Mr. Jun obtained his Engineering degree from the Mineral and Petroleum Engineering Department, College of Engineering, Seoul National University, Seoul, in 1975; in 1979, he graduated from the Graduate School of Public Administration in Seoul National University; and in 1985, he obtained his master's degree from the Energy Resources Program, Graduate School of Engineering in the University of Pittsburgh, Pittsburgh, United States of America.

Mr. Jun's various positions in his early career were as follows: from 1979 to 1983, Deputy Director in the Electric Power Policy Division, Overseas Resources Division, Ministry of Energy & Resources (MER); from 1985 to 1986, Deputy Director of the Energy Policy Division, Ministry of Energy & Resources; from 1986 to 1993, Director of the Energy Management Division, Mining Promotion Division, Petroleum Development Division, MER; from April to October 1993, Director of the Trade Information Division in the Ministry of Trade, Industry & Energy (MOTIE); from 1993 to 1998, Director of the Distribution Industry and Logistics Division, Industrial Policy Division, Energy & Resources Policy Division, Semiconductor and Electronic Components Division, MOTIE; from April to August 1998, Director of the Industrial Technology Policy Division, Ministry of Commerce, Industry and Energy.

Mr. Jun moved to the Korean Industrial Property Office (KIPO) (later changed to Korean Intellectual Property Office) where he was Director General from September to October 1998, and later became Director General of the Planning and Management Bureau in KIPO from November 1998 to January 2000. From February to December 2000, he was training at the Central Officials Training Institute; from January to March 2001, he was the Presiding Trial Examiner at the Industrial Property Tribunal, KIPO; and from April 2001 to present, is Dean of the International Intellectual Property Training Institute, KIPO

AKIHISA KAMEGAYA

Mr. Akihisa Kamegaya, a national of Japan, obtained his Master's Degree in Engineering from the Department of Material Engineering, Graduate School of Science and Engineering, Waseda University, Tokyo in March 1992.

In April 1992, he joined the Japan Patent Office and held various positions, as follows: as Examiner in the Metals and Electrochemistry Division Fourth Examination Department in April 1996; Assistant Director of the International Affairs Division, General Administration Department in August 1997; as Examiner in the Metal Processing Division, Fourth Examination Department in August 1998; was Examiner in the Logistics and Assembling Division, Third Examination Department in April 1999; and from January 2001 to the present he is the Assistant Director of the Intellectual Property Policy Office Economic and Industrial Policy Bureau in the Ministry of Economy, Trade & Industry (METI), Tokyo.

SHIRO KIMURA

Mr. Shiro Kimura, a national of Japan, is the Managing Examiner of the First Patent Examination Department, Japan Patent Office. He obtained his Bachelor's Degree in Resource Development at the Faculty of Technology, Tokyo University on March 31, 1980.

Mr. Kimura joined the Japan Patent Office (JPO) in April 1980, and was Examiner in the Construction Division, Second Examination Department in April 1984. He then moved as Research Staff in May 1985 to the Technology Research Division, Agency of Industrial Science and Technology, Tokyo. In September 1992, he became Deputy Director of the General Administration Division, General Administration Department of JPO; In June 1994, he worked as Senior Legal Staff of the PCT Legal Division at the World Intellectual Property Organization (WIPO); he then went back to the Japan Patent Office as Appeal Examiner in

the Tenth Board of Appeal in October 1997; became Associate Managing Examiner at the Applied Optics Division, Second Examination Department in April 1999. In July 2000 Mr. Kimura was Associate Managing Examiner in the Amusement Technology Division, First Patent Examination Department, and in July 2001, he became the Managing Examiner in the same Division (with the organizational restructuring which took effect on January 6, 2001, the Second Examination Department of the JPO has changed its name to the First Patent Examination).

Mr. Kimura has also given lectures at the JICA Group Training Course on Intellectual Property for APEC Economies in Tokyo in September 2000, and at the WIPO Training Course on the Examination Practices of Industrial Property under the Japan Funds-in-Trust in Tokyo in December 2000, both on "Patent Examination Procedure".

LI JIAHAO

Mr. Li Jiahao, a national of the People's Republic of China, is Deputy Director of the Cooperation for Development Bureau for Asia and the Pacific, WIPO, since December 1997. Before taking up his present duties, he held positions of Counsellor, Senior Program Officer and Senior Counsellor in the same Bureau. He joined WIPO in 1985.

Prior to joining WIPO, Mr. Li Jiahao was an official of the Chinese Patent Office (CPO), which has been renamed as the State Intellectual Property Office (SIPO), since April 1998. He studied and graduated from Sichuan University in Chengdu, and from the Postgraduate Institute of China Science and Technology University in Beijing.

MA LIANYUAN

Mr. Ma Lianyuan now serves as Deputy Commissioner of the State Intellectual Property Office, official spokesman for the Office, Vice Chairman of Directors of the China Intellectual Property Society and member of the WIPO Industry Advisory Committee.

Mr. Ma, born in 1945, is fluent in English and Japanese. He graduated from the Foreign Language Department of the Nanjing Normal University majoring in the English Language. He earned his Master of Science after attending the Graduate School of Science and Technology University of China, majoring in Machine Translation. He also went to the Industrial Property Institute of the Japanese Patent Office in 1979, and the Harvard Law School from September 1988 to September 1989 for further study of intellectual property.

After joining the Chinese Patent Office in 1981, he was Deputy Editor in Chief of the Patent Documentation Publishing House, Director General of the Legal Affairs Department and Deputy Commissioner from 1991. Mr. Ma was extensively involved in the drafting of the Chinese Patent Law and its Rules for Implementation, other patent regulations and the harmonization between the Patent Law and other laws.

Mr. Ma is also a member of various Chinese associations in the field of industrial property, including Vice Chairman of the Board of Directors of the China Intellectual Property Society and of the AIPPI (Chinese Group), and Director of the Board of Directors of the China Law Society.

NG SIEW KUAN

Professor NG Siew Kuan, Elizabeth, a resident of Singapore, is an Associate Professor of the Faculty of Law, National University of Singapore. She is currently a consultant to the World Intellectual Property Organization (WIPO), Geneva, Switzerland, and was a visiting scholar to the United States Court of Appeal for the Federal Circuit, Washington DC, United States of America.

She is the author of *Butterworths' Annotated Statutes of Singapore on Intellectual Property Law (Volume 7)* (1996), *Butterworths' Singapore Statutes Intellectual Property: Patents Act and Computer Misuse Act* (2001) and has been appointed the editor of *Halsbury's Laws of Singapore on Intellectual Property Law*.

Prof. Ng has published more than 40 publications and delivered papers on intellectual property law at international conferences in countries such as, Switzerland, People's Republic of China, Sri Lanka, Mongolia, Fiji, Thailand, Republic of Korea and Singapore.

She holds a Bachelor of Laws (Honors) from the University of London, England, and a Master of Laws (First Class) from the University of Cambridge, England. She is also a Barrister-at-Law of the Middle Temple, England, an Advocate and Solicitor of the Supreme Court of Singapore and a Fellow of the Cambridge Commonwealth Society, University of Cambridge, England.

Prof. Ng has been teaching intellectual property law at the Faculty of Law, NUS, since 1986 and has taught in both the undergraduate and postgraduate law programs. She has also taught biotechnology and related intellectual property law courses in the engineering and medical faculties. Professor Ng is also a tutor in intellectual property law of the WIPO Worldwide Academy, Geneva, Switzerland.

She has also served on committees that advise on intellectual property law aspects on national projects undertaken by the Singapore National Computer Board and the National Patent Information Centre Steering Committee. Prof. Ng regularly gives opinions on intellectual property law to clients in the public and private sectors.

SUNAO SATO

Mr. Sunao Sato, a national of Japan, is at present Associate Officer in the Cooperation for Development Bureau for Asia and the Pacific, World Intellectual Property Organization (WIPO). He is in-charge of industrial property-related activities under the Japan Funds-in-Trust Arrangement.

Before joining WIPO in May 1999, Mr. Sato was an official in the Japan Patent Office (JPO) in Tokyo where he held various posts. In 1993, he was a Trademark Examiner in the First Examination Department, and from 1995 to 1997, he became the Assistant Director of the International Affairs Division, the General Administrative Department. From 1997 to 1999, as a member of the Trademark Policy Planning Office, he was engaged in revising the Trademark Law of Japan. He also worked for the First International Organizations Division, the Ministry of Foreign Affairs of Japan (MOFA) from 1998 to 1999.

Mr. Sato holds a Bachelor of Arts degree, Major in Business Management from the Aoyama Gakuin University, Tokyo.

SHAN XIAOGUANG

Mr. Shan Xiaoguang, a national of the People's Republic of China, is currently Professor in the Intellectual Property School of Shanghai University.

KEISHIN TERAYAMA

Mr. Keishin Terayama , a national of Japan, is presently the Deputy Director-General of the First Patent Examination Department, Japan Patent Office. He obtained his Master's Degree in Physics at the Faculty of Science, Tokyo University, on March 31, 1973.

Mr. Terayama joined the Japan Patent Office in April 1973, where he held various positions: he was Examiner at the Applied Physics Division, Second Examination Department in April 1977; Appeal Examiner at the Fourteenth Board of Appeal, Department of Appeal in April 1977; Examiner at the Applied Optics Division, Second Examination Department in October 1992. In October 1996, he became the Director of the Civil Engineering Division, Second Examination Department; in April 1997 he was Director of the Business Machinery Division, Second Examination Department; in January 1998 he became Senior Director of the Agricultural and Marine Products Division, Second Examination Department; in April 1999 he was the Deputy Director-General of the Second Examination Department and in January 2001 to the present, he became the Deputy Director-General of the First Patent Examination Department. With the organizational restructuring which took effect on January 6, 2001, the Second Examination Department of the JPO has changed its name to the First Patent Examination.

Mr. Terayama has also given various lectures at the Japan Optelectro-Mechanics Association in Tokyo in 1993 and 1994 on "Industrial Property Systems;" at the Japan Patent Office (JPO) in January 1994 on "An Introduction to Optics;" and at Waseda University, Tokyo, in July 1999 on "Patent and the Technology Licensing Organizations (TLOs)".

ZHENG SHENGLI

Professor Zheng Shengli, a national of China, is a Professor of Law at Peking University School of Law. He currently serves as the Secretary General for Peking University School of Intellectual Property as well as the Vice President for Intellectual Property Society of Chinese Universities. He is also Director for Peking University Center for Study of Rule of Law. He is an authorized patent agent of China, an intellectual property consultant to courts in Beijing and a committee member of the Patent Committee of the China Intellectual Property Society.

Professor Zheng obtained his BA in atmospheric physics from the Department of Geophysics, Peking University. He was involved in research, design and teaching in the Department of Computer Science and Technology of Peking University from 1969 to 1984.

From 1985 to 1986, he studied intellectual property law in the U.S. Patent and Trademark Office, Franklin Pierce Law Center and Morgan, Finnegan Law Firm of New York; from June 1992 to 1993, he studied research on the U.S. Intellectual Property and Computer Law at the University of Washington as a Fulbright Visiting Scholar. At present he teaches master's degree subjects on advanced industrial property law, computer law and fundamentals of technology licensing at the Peking University.

Mr. Zheng is the author of a number of publications that were published in various journals; to mention a few, *Encyclopedia of Computer Science and Technology*, Shandong Press, 1993, "The Protection System of Intellectual Property in China," *The Seiwa Journal of Law & Politics* (Japan), Vol.3, No.1, September 1996 and "An Analysis of the Legal Regime on Software Protection," *Peking University Law Journal*, No.5, 1995.

Mr. Zheng has also lectured on various intellectual property subjects. He has been invited to give lectures in Tokyo University (Japan), in January 1998, on "Balance is a Basic Principle of Intellectual Property System," in the APEC/PFP Course on Management of Industrial Rights (in Thailand), November 1997, on "Social Role of Intellectual Property System" and in WIPO Asian Regional Symposium on the Role of Universities and Research Institutions in the Intellectual Property System in the 21st Century in Beijing.
